### Initial Order and Minimum Order

- The minimum opening order for new accounts within the USA is \$125.00 U.S. Minimum for international orders is \$250.00 U.S.
- All subsequent orders \$125.00 U.S.
- MasterCard, Visa and American Express accepted.
- Net 30 terms with approved credit.

### ○ Credit Terms

- Accounts over 30 days will be charged a 1.5% finance charge per month.
- Terms and conditions are effective from the date of invoice.
- Accounts over 90 days past due will be changed to pre-paid terms and referred to Collections.
- Title to merchandise remains with Hi Fidelity Entertainment until payment has been made in full.
- Hi Fidelity Entertainment reserves the right to repossess all merchandises, if not paid for according to the terms of the invoice.

### RETURN POLICY

- Hi Fidelity Entertainment must be notified within 10 days of receipt of any damaged or defective merchandise.
- All returned items are required to have a Return Authorization number. Any merchandise returned without a RMA# will be refused.
- A 15% restocking fee will be assessed on all returned merchandise unless defective or damaged.
- Credit will be issued for returned defective or damaged merchandise unless otherwise requested.
- A copy of the invoice or the shipping document must accompany all returned merchandise.
- Merchandise must be in the original packaging and in the original condition.
- All refused shipments will be charged a 15% restocking fee in addition to inbound and outbound freight. Terms to be changed to prepay-credit card.

### SHIPPING INFORMATION

- Hi Fidelity Entertainment ships your choice of UPS/USPS/FedEx. If no choice is requested, shipping will default to UPS.

### ADD ONS & BACKORDERS

- Add-ons must be placed the same business day as original order.
